Who we are; how to contact us

We are Digital Securities Exchange Limited (**DSX** or **we / us / our**). **DSX** is a company registered in England and Wales with company number 08927164 and its registered address is: Palladium House, 1-4 Argyll Street, London W1F 7LD, United Kingdom.

At **DSX** we believe in being clear and open about how we collect and use data related to you. In the spirit of transparency, this notice provides detailed information about how and when we use cookies. This cookie notice applies to any DSX product or service that links to this notice or incorporates it by reference.

What is a cookie?

A cookie is a small piece of data (text file) that a website, when visited by a user, asks your browser to store on your device in order to remember information about you, such as your language preference or login information. Those cookies are set by us and called first party cookies.

We also use third party cookies, which are cookies from a domain different than the domain of the website you are visiting, for our advertising and marketing efforts.

More specifically, we use cookies and other tracking technologies for the following purposes:

- Assisting you in navigation;
- Assisting in login and your ability to provide feedback;
- Analysing your use of our products, services, or applications;
- Assisting with our promotional and marketing efforts (including behavioural advertising).

Does DSX use cookies?

Yes. As described in part 'f' of the table at section 3 of the Privacy Notice we use cookies and other technologies to ensure everyone who uses DSX has the best possible experience.

Cookies also help us keep your account safe. By continuing to visit or use our services, you are agreeing to the use of cookies and similar technologies for the purposes we describe in this Cookie Notice.

When does DSX place cookies?

We use cookies on our sites and mobile applications. Any browser visiting these sites will receive cookies from us.

You can opt-out of each cookie category (except strictly necessary cookies).

What types of cookies does DSX use?

We use the following types of cookies: session cookies, secure cookies and httponly cookies. Session cookies only last for as long as the session (usually the current visit to a website or a browser session). A secure cookie is only transmitted via HTTPS, which you will typically find in the checkout pages of online shopping sites. This ensures that any data in the cookie will be encrypted as it passes between the website and the browser. An HTTPOnly Cookie is used when a cookie has an HTTPOnly attribute set, the browser will prevent any client script in the page (like JavaScript) from accessing the contents of the cookie. This protects it from so-called cross-site-scripting (XSS) attacks, where a malicious script tries to send the content of a cookie to a third -party website.

What are cookies used for?

Cookies can be used to recognise you when you visit DSX, remember your preferences, and give you a personalised experience that's in line with your settings. Cookies also make your interactions with DSX faster and more secure. Additionally, cookies allow us to bring you advertising both on and off the DSX sites and bring customised features to you through DSX plugins.

What types of cookies does DSX use?

Categories of Use	Description
Authentication	If you're signed in to DSX, cookies help us show you the right information and personalise your experience.
Security	We use cookies to enable and support our security features, and to help us detect malicious activity and violations of our User Agreement.
Preferences, features and services	Cookies can tell us which language you prefer and what your communications preferences are. They can help you fill out forms on DSX more easily. They also provide you with features, insights, and customised content in conjunction with our plugins. You can learn more about plugins in our Privacy Notice .
Advertising	We may use cookies to show you relevant advertising both on and off the DSX site. We may also use a cookie to learn whether someone who saw an ad later visited and took an action (e.g. downloaded a white paper or made a purchase) on the advertiser's site. Similarly, our partners may use a cookie to determine whether we've shown an ad and how it performed or provide us with information about how you interact with ads. We may also work with a partner to show you an ad on or off DSX, such as after you've visited a partner's site or application.
Performance, Analytics and Research	Cookies help us learn how well our site and plugins perform in different locations. We also use cookies to understand, improve, and research products, features, and services, including when you access DSX from other websites, applications, or devices such as your work computer or your mobile device.

Do Not Track” Disclosures

“Do Not Track” is a standard that is currently under development. As it is not yet finalised, DSX adheres to the standards set out in this [Privacy Notice](#) and does not monitor or respond to Do Not Track browser requests.

How are cookies used for advertising purposes?

Cookies and other ad technology such as beacons, pixels, and tags help us serve relevant ads to you more effectively. They also help us provide aggregated auditing, research, and reporting for advertisers, understand and improve our service, and know when content has been shown to you. Note: Because your web browser may request advertisements and beacons directly from third party ad network servers, these networks can view, edit, or set third party cookies, just as if you had requested a web page from their site. Ads served by DSX may also set third party cookies.

If you are logged in on DSX.uk or another Service that references this Cookie Notice or browsing a third-party partner site of DSX and one of our cookies on your device identifies you, your usage (such as your browsing behaviour) and log data (such as your IP address), will be associated by us with your account as noted in parts ‘d’ and ‘f’ of the table at section 3 of the Privacy Notice. We also use aggregate data from third parties and data from your profile and DSX activity.

What third-party cookies does DSX use?

Our [cookie table](#) lists some of the third-party cookies on our sites. Please note that the names of cookies, pixels, and other technologies may change over time.

Controlling cookies

Most browsers allow you to control cookies through their settings preferences. However, if you limit the ability of websites to set cookies, you may worsen your overall user experience, since it will no longer be personalised to you. It may also stop you from saving customised settings like login information.

What to do if you don’t want cookies to be set or want them to be removed?

If you do not want to receive cookies, you can change your browser settings on your computer or other device you’re using to access our services. If you use DSX without changing your browser settings, we’ll assume that you’re happy to receive all cookies on the DSX website. Most browsers also provide functionality that lets you review and erase cookies, including DSX cookies. Please note that the DSX site will not work properly without cookies.
